Go 4.6 miles and turn right on Custer Road. Go 1.3 miles to Standing Rocks Road. The park will be 1.2 miles down the road on the right side and parking will be on the right.

Entries: Sectional Tournament Information

- 1. A tournament team consists of a maximum of seven individuals.
- 2. A school may enter less than a full team (1-4) for individual competition.
- 3. A school is expected to provide their meet manager, by a designated date, an alphabetical list of its participants for purposes of publicity, and programs.
- 4. Entries will be made on-line at: www.pttiming.com | Instructions for On Line Entries
- 5. Deadline for entries is 11:59 p.m., Tuesday, October 22.
- 6. Any school that misses the entry deadline will still be allowed to enter but their reimbursement will be withheld if their team or individual(s) qualify for the State Meet. The WIAA will also send a letter of reprimand to the school's administration.
- 7. Alternates It is not a requirement to list alternates when doing entries. However, if alternates are listed it assists the timing services in making changes to the line-up (listing 3 alternates is an appropriate number). The make-up of your team may change from sectionals to State (this does not apply to individuals who have qualified for State).

AWARDS:

7 gold medals to the first-place boys and girls teams 7 silver medals to the second-place boys and girls teams

Medals (5 bronze) to the first 5 individuals who are not members of a qualifying team, with the individual sectional champion receiving the gold medal (even if he/she is a member of the championship team).

1 gold medal for overall individual sectional champion (in addition to team or individual qualifying medal).

Tickets/Admission: Advanced Purchase

- 1. Before Arriving at the Gate:
 - Access your confirmation email and click on the "VIEW TICKET" option on your mobile device.

 - Show your mobile device to the gate personnel at the 4 marked entrances.
 - The event staff will validate your admission ticket.
- 3. Important Note:
 - Do not validate your ticket prior to arriving at the gate.
 - If you validate your ticket in advance, you will need to purchase another ticket.
- 4. Ticket Format:
 - Tickets cannot be printed.
 - You must use your mobile device to access your ticket(s).

Stockton & Amherst First Responders will have a medical vehicle on site, following the runners.


PARKING:

Course Maps




Bus Parking & Spectator Parking:
